Tournament Pricing

Weekend (Fri.- Sun.) shotgun tournaments are priced at \$55.00 per player. This includes one 18-hole round of golf with ½ a cart and range balls.

Weekday (Mon. – Thurs., excluding holidays) shotgun tournaments are priced at \$45.00 per player. This includes one 18-hole round of golf with ½ a cart and range balls.

The Freeport Golf Course has partnered with La Casona for our tournaments! The La Casona package is a catering package we will offer our tournaments; it consists of an enchilada plate (with rice and beans) with a side of chips and salsa. It would be an additional \$15 per player, making it \$70 per player for a weekend tournament and \$60 per player for a tournament during the week.

Tournament Deposit

All groups or organizations wishing to book an event must submit an application form. Tournament dates are granted on a first come first-serve basis, inclusive of a completed application.

Tournament Services

Tournament services include:

Use of the covered pavilion, professional score cards, rule sheet, use of range with range balls, beverage cart service, and scoreboard and scoring. **You are allowed to cater in your own food for no additional cost.**

A \$200 DEPOSIT IS REQUIRED BEFORE TOURNAMENT DAY

Tournament Regulations

All applicants must understand and comply with the following tournament and user regulations:

1. The Freeport Golf Course must receive notification of the number of players **at least 7 days in advance** of the confirmed event date. All no shows must be paid for.
2. **GOLF CARTS:**
 - a. The course golf cart fleet consists of 50 carts available for tournament use. Additional carts that are needed to accommodate the group reserved through the Golf Professionals in adequate time to assure their availability. The course is not responsible for non-availability of additional carts. If additional golf carts are needed, the group will be charged for a minimum of 50 carts, plus any additional cost, including minimum deliveries, cancellation fees, etc. incurred by the professional for the additional carts rented. All golf cart operators must be 16 years old or older and hold a valid driver's license. The group will be charged the full cart fee for any carts used by non-golfers. The group is responsible for any improper use or damage to the cart or golf course caused by the use of carts by their players and their guests.
3. **GOLF:**
 - a. The course will endeavor to present the golf course in the best possible playing condition for your tournament; however, circumstances beyond our control may, at times, create less than ideal conditions. As long as the golf course is deemed playable and all 18 holes are available, no allowances will be given. At certain times during the year, course maintenance procedures may be required, which may include aerification, topdressing, over-seeding, etc. and will be carried out as weather permits. The course cannot delay our schedule due to any pending events. The course will not perform any of this maintenance on the actual day of your tournament, and will make every effort to schedule normal maintenance as to not affect scheduled events. Weather dependent, a cart paths only play will be at the discretion of the course Superintendent.
4. **The Freeport Golf Course is a licensed facility and therefore, only alcoholic beverages purchased from the beverage cart and/ or the pro-shop will be permitted. Beverage coolers are not permitted on the golf course. Those that insist on consuming or attempting to consume their own alcoholic beverages on the golf course, or its premises, will be removed without the possibility of any refund for prepaid fees and/or rentals.**
5. Each player must have a separate set of clubs.
6. All patrons of the Freeport Golf Course are responsible for any damages that they may cause to the golf course, power carts, equipment, and the clubhouse.
7. It is the responsibility of the tournament organizer to ensure all participants are aware of these rules and regulations.
